

# REDIRECTION INFORMATION



**O**ne component of conscientious war tax refusal can be a commitment to redirect the resisted taxes to projects that conform with the war tax resister's conscience and serve the common good. The redirection can be a positive public face of the act of conscience. When it is done with others, the amount redirected can be significant both to the recipient groups and as a direct action model for shifting federal spending from war to the needs of people.

The 2009 War Tax Boycott campaign is recommending two redirection projects for your consideration (or you may decide to redirect to a project of your own choosing):

**Electronic Iraq's Direct Aid Initiative (DAI)** provides Iraqi refugees in Jordan and Syria with medical care. You can read about the lives and view photographs of those who have received medical care through DAI at <http://electroniciraq.net/news/directaidinitiative/index.shtml>. If you choose to donate your resisted taxes to DAI, your check should be made out to: **"MECCS/DAI"**\* and mailed to **MECCS/DAI, PO Box 382425, Cambridge, MA 02238**.

**Common Ground Health Clinic (CGHC)** in the Algiers neighborhood of New Orleans provides health care to Katrina survivors. CGHC is attempting to replace services that no longer exist and to be a new model of free, neighborhood-based preventive care. You can learn about the clinic at <http://cghc.org>. If you choose to donate your resisted taxes to CGHC, your check should be made out to: **"Common Ground Health Clinic"**\* and mailed to **Common Ground Health Clinic, 1400 Teche St. New Orleans 70114**.
